Some results on G-frame operator in quaternionic setting

G frames are a natural generalization of frames which cover many other extensions of frames. Quaternions are an extension of complex numbers from the twodimensional plane to four-dimensional space and form a non-commutative associative algebra. Due to the non-commutativity, there are two types of Hilbert spaces over quaternions, called right quaternionic Hilbert space and left quaternionic Hilbert space. In this research G-frame operator for G-frame in left quaternionic Hilbert space $V_{\mathbb{H}}^{L}$ is introduced and some results of G-frame operator are presented and one can easily obtain these results on right quaternionic Hilbert space $V_{\mathbb{H}}^R$ by the symmetry. Let $U_{\mathbb{H}}^L$ and $V_{\mathbb{H}}^L$ be two left quaternionic Hilbert spaces and $\{\mathcal{V}_k \colon k \in \mathbb{I}\} \subseteq V_{\mathbb{H}}^L$ is a sequence of quaternionic Hilbert spaces. A family of sequence $\{\Lambda_k \in \mathcal{B}(U_\mathbb{H}^L, \mathcal{V}_k): k \in \mathbb{I}\}$ is called generalized frame or simply G-frame for $U_{\mathbb{H}}^L$ with respect to $\{\mathcal{V}_k \colon k \in \mathbb{I}\}$ if there exist constants $0 < A \leq B < \infty$ such that $A\|f\|^2 \le \sum_{k \in \mathbb{I}} \|\Lambda_k f\|^2 \le B\|f\|^2$, for all $f \in U^L_{\mathbb{H}}$, where A and B are G-frame bounds. We $\operatorname{call}\left\{\Lambda_k\in\mathcal{B}\big(U_{\mathbb{H}}^L,\mathcal{V}_k\big)\colon k\in\mathbb{I}\right\} \text{ is a tight G-frame if }A=B.\text{ If }\{\Lambda_k\}_{k\in\mathbb{I}}\text{ is a G-frame in }U_{\mathbb{H}}^L$ with G-frame operator S^G if and only if $AI_{op} \leq S^G \leq BI_{op}$ and $\{\Lambda_k\}_{k \in \mathbb{I}}$ is Gnormalized tight frame in $U_{\mathbb{H}}^{L}$ if and only if $S^{G} = I_{op}$, where I_{op} is an identity operator in $U^L_{\mathbb{H}}.$ If S^G is a G-frame operator for the G-frame $\{\Lambda_k\}_{k\in\mathbb{I}}$ with frame bounds A and B in $U_{\mathbb{H}}^{\mathbb{L}}$ then $B^{-1}I_{op} \leq S^{G^{-1}} \leq A^{-1}I_{op}$. Finally sequence of operator $\left\{\widetilde{\Lambda_k}\right\}_{k\in\mathbb{I}} \text{ (where }\widetilde{\Lambda_k} = \Lambda_k S^{G^{-1}}\text{) is G-frame for the quaternionic Hilbert space }U^L_\mathbb{H} \text{ with }$ frame bounds $\frac{1}{B}$ and $\frac{1}{A}$. We have seen that a sequence of operators is a G-frame for the left quaternionic Hilbert space $V_{\mathbb{H}}^L$ with frame bounds $\frac{1}{R}$ and $\frac{1}{A}$.
